Protective measures

Fut on appropriate personal protective equipment (see Section 8). Do not swallow. Aspiration hazard if swallowed. Can enter lungs and cause damage. Never siphon by mouth. Section 8. Exposure controls and personal protection

Appropriate engineering controls
