This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak "is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

### **Section 4 - First Aid Measures**

#### **General Information:**

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** If irritation occurs, contact a Poisons Information Centre, or call a doctor. Remove source of contamination or move victim to fresh air. If breathing is difficult, oxygen may be beneficial if administered by trained personnel, preferably on a doctor's advice. In severe cases, symptoms of pulmonary oedema can be delayed up to 48 hours after exposure.

**Skin Contact:** If significant skin contact occurs, seek urgent medical attention. Quickly and gently, blot or brush away excess chemical. Remove contaminated clothing, shoes and leather goods.(e.g. watchbands, belts). Flush contaminated area with lukewarm, gently flowing water for at least 60 minutes, by the clock. DO NOT INTERRUPT FLUSHING. If necessary, keep emergency vehicle waiting.

**Eye Contact:** Call a Poisons Information Centre or a doctor urgently. Quickly and gently, blot or brush away chemical. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water while holding the eyelid(s) open until advised to cease by trained medical attendant. Neutral saline solution may be used as soon as it is available. DO NOT INTERRUPT FLUSHING. Take care not to rinse contaminated water into the unaffected eye or onto face.

**Ingestion:** If swallowed, rinse mouth thoroughly with water and contact a Poisons Information Centre. Urgent hospital treatment is likely to be needed. Give activated charcoal if instructed.

## **Section 5 - Fire Fighting Measures**

**Fire and Explosion Hazards**: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. In contact with some reactive metals, may react liberating hydrogen gas which forms explosive mixtures with air.

No fire decomposition products are expected from this products at temperatures normally achieved in a fire.

**Extinguishing Media:** Water fog or fine spray is the preferred medium for large fires. Aim to dilute the material with large quantities of water. If practical, contain diluted material and prevent from entering drains and water courses.

Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. # Section 7 - Handling and Storage

Handling: Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

Storage: This product is a Scheduled Poison. Observe all relevant regulations regarding sale, transport and storage of this class of poison. Store in a cool, well ventilated area. Check containers periodically for corrosion and leaks. Containers should be kept closed in order to minimise contamination. Make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. If you keep more than 500kg or 500L of Corrosive Substances of Packaging Group II, you will require a license to do so. ## Inhalation

**Short term exposure:** product is an inhalation irritant. Symptoms may include headache, irritation of nose and throat and increased secretion of mucous in the nose and throat. Other symptoms may also become evident, but they should disappear after exposure has ceased.

Long Term exposure: No data for health effects associated with long term inhalation.

### **Skin Contact:**
